How we make a difference through giving

Giving is core to our culture at Microsoft and how we live our mission. We believe our employees' time, money, and skills are valuable resources to help nonprofits accelerate their missions. Our employees take part in fundraising opportunities, special projects with their work teams or families and friends, micro-volunteering, and they donate time with their professional skills.

Because of the Microsoft Give Match, employees are empowered to do more for the causes they care about. Key features of our employee giving program include:

- **One-to-one match limit of up to a combined USD15,000**, or local equivalent, per eligible employee, per calendar year*
- **Volunteer time matched at USD25 per hour***
- **Purchase and donate items** from the Microsoft Store (microsoft.com) or a company store*



In Calendar Year 2025, Microsoft employees volunteered 1.24 million hours—that's 142 years of time in one year—and donated over USD255 million (including company match) to 36,500 nonprofits and schools around the globe. Our year-round Employee Giving Program is open to US tax-exempt 501(c)3 or international equivalent public charities registered with Benevity that meet program eligibility criteria.

How nonprofits get involved

Registered 501(c)(3) nonprofit organizations and international equivalents must register with Benevity, our third-party giving vendor at benevity.com/nonprofits, to become eligible in Microsoft's program, and Benevity's other corporate client programs. Note: Benevity is a platform used by multiple corporations, their registration process may ask for questions and actions beyond what is required to participate in Microsoft's program. A nonprofit that verifies its 501c3 or equivalent status will be available to Microsoft employees.
